

P2P Global Investments plc (the “Company”)

DIVIDEND DECLARATION

On the 26 October 2016, the Directors have declared an interim dividend of 11p per ordinary share for the three month period to 30 September 2016. Of the 11p, 8.9p will be paid from the Company's revenue reserve and 2.1p from the special distributable reserve which relates to gains from the Company's share buyback's.

The dividend will be paid on 25 November 2016 to shareholders on the register as of 4 November 2016. The ex-dividend date is 3 November 2016.

The Company has elected to designate all of the interim dividend for the three month period to 30 September 2016, as an interest distribution to its shareholders. In doing so the Company is taking advantage of UK tax treatment by "streaming" income from interest-bearing investments into dividends that will be taxed in the hands of shareholders as interest income.

Investors who are eligible to receive the interest distribution without deduction of UK tax should complete the Declaration of Eligibility Form which can be found on the Company's website www.p2pgi.com.

The last date for elections for the Dividend Reinvestment Plan, available on the ordinary share class, is 4 November 2016.
